PROSPER APPEAL GRANTED

MOOSE LAKE: THE COURT OF APPEAL CASE


On January 16, 2019 the Alberta Court of Appeal granted "permission" for Fort McKay First Nation to bring an appeal challenging the Alberta Energy Regulator's decision last June 12th to allow the Prosper Rigel project to go ahead.

"PERMISSION TO APPEAL" - WHAT THAT MEANS.

Fort McKay First Nation brought an application for <u>permission</u> to appeal, and a judge of the Court of Appeal decided to grant permission. You won, and this is the first step towards winning the full appeal, but it is just the first step. Usually a decision of the Alberta Energy Regulator is final and there is no appeal. The exception is an appeal on a legal point, but even on a legal point the appeal can only be started if the Court of Appeal grants "permission" to appeal. There were three reasons why Fort McKay wanted permission to appeal, and all of those reasons were rejected by the court except for one. But one is enough, and now the appeal can go forward.

PROSPER APPEAL GRANTED

(Story continued from p. 1)

THE NARROW GROUND THAT CAN BE APPEALED.

The Court of Appeal dismissed most of Fort McKay's reasons for wanting the appeal, but allowed this one:

"Did the AER commit an error of law or jurisdiction by failing to consider the honour of the Crown and, as a result, failing to delay approval of the Project until the First Nation's negotiations with Alberta about the MLAMP are completed?"

This means that the Court of Appeal will look into the fact that the Regulator approved the Prosper Rigel project even though the Moose Lake Area Management Plan was not completed.

WHAT DOES THIS MEAN FOR PROSPER RIGEL?

Realistically, this puts the project on hold. The project is not technically on hold because of this decision, but if the Alberta cabinet decides to allow Prosper to go ahead now, we would have a stronger case to get an injunction until the appeal can be heard. As a practical matter it is unlikely that Prosper will try to go ahead because their lawyers will have advised them that they should wait for the appeal to finish. The hearing of the appeal will be several months from now. The decision on the appeal may not be ready for six months or more. Until then, the Prosper Rigel project is unlikely to proceed.

WHAT COULD HAPPEN AT THE APPEAL?

The Court of Appeal could decide either way. They could decide that because Alberta did not act honourably, the AER decision made on June 12, 2018 must be set aside, and the Prosper Rigel project is dead (for now). Or they could dismiss the appeal and say that the government of Alberta acted just fine and allow Prosper Rigel to go ahead. Or, they could do many things in between those two extremes. A possible order from the court might force the government of Alberta to finish negotiations about the Moose Lake Area Management Plan before the Regulator can consider the Prosper Rigel project a second time. This would be quite a victory, but it is not a certain result.

DOES THE APPEAL DECIDE EVERYTHING?

The appeal is only on a special question – which is whether the government of Alberta acted properly when they dropped the MLAMP negotiations. It does not stop Prosper forever, only temporarily. It does not decide anything about treaty rights. Meanwhile, Fort McKay has several other legal proceedings waiting to go to court, and any one of them could also stop the project, either temporarily or permanently. The main legal case is the treaty rights case filed on December 3, 2018. One benefit from this Court of Appeal decision is that it gives us more time to prepare for that case, if it is needed.

WHAT ABOUT NEGOTIATIONS?

This decision gives Fort McKay First Nation an excellent bargaining position. Prosper would be wise to work with FMFN to design a project that does not threaten Moose Lake. Alberta would be wise to finish the MLAMP negotiations. Both of those things give FMFN negotiating power. The window for these negotiations is the next six months or so, until the appeal is heard and decided.

The Alberta Court of Appeal's decision is called: <u>Fort McKay First Nation v Prosper Petroleum Ltd.</u>, <u>2019 ABCA 14.</u>

A FRIENDLY REMINDER From the Fort Mckay Medical Transportation

- All medical appointments should be made in advance for prior approval (24 notice). Any last minute booking must come from the community health nurse. To avoid any delays on medical transportation services.
- Policy states that only 1 (one) medical visit to the family physician every 2 weeks, unless
 otherwise requested by your family physician and a medical note must be provided to the medical
 transportation coordinator for your file.
- Clients should be contacting the Medical Transportation Coordinator to book any transportation services, and Edmonton Referral@l-800-514-7106 for after hour services. Do not contact the medical driver for appointments.
- It is the client's responsibility to ensure confirmation of appointment letters are sent from their doctor/dental/specialist appointments to the medical transportation coordinator prior to booking Fax 780-828-4132. (PLEASE NOTE): This is not the Medical Coordinator's responsibility•
- If requiring an escort, clients must ensure to provide the proper documentation to the Medical Transportation Coordinator.
- It is the client's responsibility to contact the Medical Transportation Coordinator if they will be cancelling the transportation services, as soon as possible. Failing to do so will flag the client's file, resulting in no access to transportation services unless the client has provided proof of attendance to the scheduled appointment.


